Reason of modification:

From 1 May 2025, in case of the fees highlighted in gray, as a promotion the Bank will not apply the fee increases announced with effect from 1 April 2025 due to changes in the consumer price index. In the case of fees highlighted in gray, the measure of the discounted fee can be found in the announcement titled "Announcement on discounted fees effective between 1 May 2025 and 30 June 2026 for private clients". The related promotional period is valid until withdrawal, but no later than 30 June 2026.

Conditions, fees and charges not included here shall be governed by the effective „List of Conditions of KDB Basic Account Package for Private Persons“ (henceforth: List of Conditions).

Fees specified in the present announcement are valid for 1 year from the date of entry into force of the account package contract concluded from August 22, 2016, which fixed term – unless the Bank’s written notification to the contrary – will automatically be prolonged by 1 year, but will not be prolonged more than 2 consecutive times. If the account package will not be prolonged, the conditions shall be governed by the effective List of Conditions instead of the account package conditions contained in the present announcement from the day indicated in the Bank’s notification.

All issues which are not regulated by the present announcement shall be governed by the related General Terms and Conditions, Business Regulation on financial services and financial auxiliary services, the General Terms and Conditions on payment accounts, payment services and deposits, the General Terms and Conditions on VISA CHIP debit bankcards, the Business Regulation regarding electronic and phone banking services, the List of Conditions and the Deposit Announcement on payment accounts and term deposits of retail clients published by the Branch, and the effective legislation.

¹ The package fee is due on the last working day in each month. The Bank payment account usage is to be examined one day before the last working day of the month and the fee is calculated and charged based on that.

² For those customers who have entered into a loan agreement with BG Magyarország Ingatlanfinanszírozási Zrt, the monthly minimum amount to be transferred to the payment account is HUF 250,000.

³ The package fee contains a free of charge HUF payment account and a free of charge payment account in foreign currency (in EUR, USD or GBP).

⁴ The regular fee of the transaction is HUF 232 + (0.45% max. HUF 20,000). The special offer is valid until withdrawal.
